In addition to these streams the college has also introduced a series of skill based courses which have attracted the students and gave opportunities to them to get jobs in different sectors.**
- 2. In the field of co-curricular and extracurricular activities the college has paid full attention. To create national and international players from the college and its surrounding area the authority has established an international standard Gymnasium hall. It has been fulfilling the long awaited demands of the students as well as the local people. Many of the trainees of the Gymnasium hall have already earned national international fame.**
