2. Last date of submission of bid document is 19/06/2017 till 3 PM.
3. The intending bidders are expected to see the site of the proposed work at his/their own cost and collect necessary information required by him/them before submitting tender. If required he/she may take the help from construction committee concerned for site visit.
4. No tender will be accepted after the stipulated date and time as mentioned.
5. The work may be increased or decreased as per need of this office and no payment will be considered against incomplete work and found not satisfactory by this office.
6. The undersigned reserves the right to accept or to reject any or all tenders without assigning any reasons whatsoever and he does not bind himself to accept the lowest rate.

7. No materials will be supplied for any of the above works by this office. All taxes, Forest Royalty etc required in connection with the work to be borne by the selected bidder.
8. The bidders will have to furnish the following with the tender.
 - i) One copy of passport size photograph of the bidder.
 - ii) Court fee stamp of Rs 8.25.
 - iii) Copy of up to date Registration Certificate from PWD (B) Class –I (A, B & C) of State/Central Govt.
 - iv) Bid Security/Earnest Money in the form of Demand Draft pledged to **“The Principal, Swahid Peoli Phukan College, Namti** payable at SBI, Chapangani Branch (IFSC- SBIN0007429).
 - v) Copy of Work order/Certificate issued by not below the rank of Executive Engineer for the last 3(three) financial years namely 2014-2015, 2015-2016 and 2016-2017. The bidder should execute as a prime contractor at least one civil work of value not less than 30%, 60% & 80% respectively, value of works as mentioned above completed in the last 3 years . The authenticity of such certificate will be verified in the respective department by the undersigned. If any manipulation is found the award of contract will be terminated and necessary action will be taken against the contractor.
 - vi) The bidder/bidders submitting tenders in the name of a firm will have to execute and furnish a copy of power of attorney.
 - vii) Copy of up to date Labour License.
 - viii) Copy of PAN.
 - ix) Copy of VAT/GST registration/ clearance certificate/WC-2 Certificate.
 - x) Copy of valid class-I electrical licence for executing building electrification works (in the event of the works being sub-contracted, the sub contractor should have the necessary license).
 - xi) Bid validity undertaking that the bid shall remain valid for a period of 180 days.
 - xii) Copy of Income Tax return for the financial year 2016-17.
 - xiii) Under taking that the bidder will be able to invest minimum 25% of contract value of work, during implementation of work.
 - xiv) Affidavit by the bidder.
 - xv) Financial sound certificate from the bank
9. The successful bidder must have to start the work within 7days from the date of issue of formal work order from the undersigned following the agreement in APWD F-2 Form before the undersigned. The work will be executed under the supervision of concerned authority.
